Our goal is to make the "product sourcing" process for the companies as seamless as possible.


By using the latest cloud technology and advanced data tools, we believe getting all stakeholders on the same page and provide them with "full transparency" is what separates us from the competition.


OUR ACTIVITIES

HOW WE WORK

Below are the steps we follow for each transaction:

PRODUCT SELECTION:

If our customers are not sure about which product would best fit their needs, we provide a complimentary consulting session and determine the best product for their project.

AUTOMATED DISPATCH:

We follow our "Mirava Case System" where each order is assigned to a specific team and the same individuals follow the shipment until the delivery is finalized.

From receiving the "purchase request" to "final delivery" at port, our entire business process is automated and verifiable by our clients.

▶ INTEGRATED LOGISTICS:

Depending on the desired destination, the products can be shipped either from Germany or Turkey. We always chose the most convenient and cost-effective location.

CUSTOMS & COMPLIANCE:

In tandem with our logistics partners, we offer customs clearance services at the destination port. If clients are not familiar with the process, our team of experts will guide them through each step and ensure that smooth customs clearance will take place before the final delivery.
